Sub : Retirement list of Officers/Police Personnel/Ministerial Staff/CFs/Hospital Staff for the year 2018.

Ref : G.O(P)170/2012/Fin., dated 22/03/2012.

The list of Officers/Police personnel/Ministerial Staff/Hospital Staff/CFs/PTS etc. of this unit who are due to retire from service on superannuation with effect from the After Noon of the last day of the month in which they attain the age of 56 years on superannuation during the year 2018 is furnished below. They will be relieved of their duties on the due date after collecting back all the Government properties which are to be surrendered before their retirement from service and they would not be retained in service beyond that date on any account. Liabilities, if any, outstanding against these retiring officers should be assessed and reported to this office sufficiently early to effect the recovery from their last pay. Separate report should be sent by the Station House Officers/Unit Heads concerned to this office soon after the officer concerned is relieved of his/her duties on retirement. If anyone is received on transfer from any other units and if anyone is reinstated into service after suspension/dismissal is found due for retirement on superannuation during the year 2018 after the issue of this C.O, their Name, Rank, Date of Birth etc. should be reported to this office by the officers concerned under whom he is working without fail for verification and incorporation of their names.

The Deputy Commandant, AR Camp, Kollam City, all Sub Divisional Police Officers, Circle Inspectors and Station House Officers are hereby directed to verify the date of birth of all Police personnel working under them with reference to their SSBs/MH Sheet etc and report immediately to this office if the name of any person (Who is due to retire from service during the year 2018) was excluded from the list furnished. If any error is noticed in the list after verification of SSBs/MH Sheet etc., that fact should be reported to this office forthwith. It may also be noted that, if anybody happens to retain in service and draw/receive pay and allowances after the date of retirement as mentioned in the list, the officer concerned and the Station House Officers/Unit Heads concerned will be held responsible for the lapses. The Unit Heads/section concerned in DPO, Kollam City/Secretary, Kollam District Police Dept. Employees Co-operative Society, and KPHCS, Ernakulam will furnish the liabilities towards Government/quarters/water charge/electricity charge/profession tax/leave settlement/KPW&A Fund loans/Tour Advance/excess pay drawn/MCA/HBA/CA/Telephone charge/Departmental disciplinary proceedings (OE/Non-OE)/Judicial or Vigilance case enquiry etc pending against those retiring employees sufficiently early, so that their pensionary benefits can be released without delay.

Copies of this CO will be circulated among each personnel whose name is included in the list and obtain their dated signature on list against their names and returned to this office through 'iAPS' duly certified by Station House Officers/Unit Heads to the effect that as follows.

1. Certified that the list has been circulated among all concerned working in this station/unit, obtained their dated signature and that nobody is excluded from the

2. And that the list has been verified and found correct and none of this unit due to retire during the year 2018 has been excluded from the list. (If excluded, the name, rank, designation, date of birth, date of retirement etc may be furnished for inclusion of the list).

The Unit Heads/SHOs concerned should forward the following reports to District Police Office, Kollam City within 3 days from the date of retirement of employee concerned.

1. Liability/Non liability report to pension sections of CPO

2. No Leave Roll Pending report to leave section of CPO

The Officers concerned will direct the personnel to submit formal application for pension with the following documents to CPO, Kollam urgently.

1. Pension Book (2 Copies). The retiring person will fill up the 5, 7, 8, 23, 27, 29, 31, 33,37 & 41 pages of the pension book.

2. Descriptive Roll and Identification particulars (3 Copies) duly attested by the CI concerned.

3. Three copies of single photograph(one copy in uniform without attestation) & two copies of joint photographs of the retiring person with his/her spouse duly attested by CIs concerned.

4. Nomination for Life Time Arrears of Pension (Form A) (3 Copies)duly attested by the CIs concerned.

5. Details of family in form 5A(3 copies)duly attested by the CIs concerned.

6. Permanent address after the retirement to which communications have to be sent (3 copies).

All Gazetted Officers may send their formal applications for pension along with the required documents to this office at least one year before their retirement without waiting for any intimation either from this office or from the Office of the Accountant General (A&E), Kerala, Thiruvananthapuram.

The following instructions are also to be noted as guidelines in pension matter.

GPF Closure

On his/her option, the subscriber can stop the subscriptions to GPF account within one year of his retirement and apply for closure of accounts in advance. This chance can be utilized by the retiring personnel in order to receive their GPF closure amount without delay.

Terminal surrender

The terminal surrender of E.L. can be sanctioned to a retiring person immediately after his/her retirement without waiting for an application from the individual. The leave section in City Police Office will ensure early action in this account.

FBS

As per G.O(P)255/90/Fin dtd. 28/4/1990, the subscribers to Family Benefit Scheme are given option to remit the subscription in lump for the last six months prior to retirement for speedy settlement of the claim. The retiring person can utilize the chance in time. He can submit application to CPO well before 6 months for the recovery of FBS subscription in lump. The FBS section in CPO will see that early action is taken to get the FBS account transferred to this District from outside units. If the retiring person has worked in other units prior to retirement much care should be taken to up to date the register-cum-Broad sheet in respect of the individual. It should also be ensured that the reconciliation of the up-to-date account of the subscriber is done sufficiently early before the retirement of the subscriber.

GIS

As in the case of FBS, option for recovery in lump of six months premium to General Insurance can also be made. But the final settlement of the scheme will be taken up only after the date of retirement of a person, to ensure continued Insurance coverage envisaged in the scheme. Application in Form 3 should be obtained well in advance and the entries in the pass book made up-to-date.



Proposals for final payment send to the Director of Insurance without much lapse of time.

Lump-Sum Grant from KPW&A Fund

In the case of Lump-sum Grant from KPW&A Fund to a retiring person as admissible in GO(MS) No. 1196/81/Home dtd. 03/12/1981, the amount should be calculated well in advance after obtaining the details of recovery of subscription from former units. The concerned section will take early action in the matter. There may be cases in the rest of time the service books of transferred personnel are received in this office, service book section Clerk will check up at the time of receipts of service book of each individual from other units whether the particular person is ripe for retirement and if so, without any lapse of time, the position may be brought to the notice of pension section in order to issue appropriate orders in such cases. Please note that this is an important task to observe on the part of Service Book Section Clerk in order to avoid any faults in the matter.
